

We will wait and see before formulating a plan of action," Chenna Siddarama Pandithardahya Shivacharya, the pontiff of Shrishaila Peeta, one of the Pancha Peetas, was quoted as saying in the media. The government is now keen on amending another vexatious legislation, the Karnataka Agricultural Produce Marketing (Regulation and Development) (Amendment) Act, 2020.
